I agree that the user of the images and I will be responsible for dealing with any public or other enquiry or feedback on the use of the images and the said user and I will inform the public promptly should the situation arise.
5. I am fully aware that my order is processed only after written permission for use and reproduction has been obtained by me or on behalf of the user from all concerned. In my application for clearance I will state that the user and I agree that NAS will not be responsible for dealing with any public or other enquiry or feedback on the use of the images.
6. I will not distribute or reuse the images except with written permission from the NAS. I agree that the copies of images provided to me will only be used for the specific purpose stated in the order form and that I will ensure the copies will not be retained or stored in any media and will be destroyed/deleted after the stated purpose has been served.
7. Orders will be processed only when full payment has been made. Orders must be collected within **3 months** from the date of order and uncollected reproductions will be destroyed without any refund or notice. An order automatically expires if payment is not received within 21 days of the date stated below.
9. Payment may be made in cash, NETs (both at the Archives Reading Room), or cheque made payable to NATIONAL HERITAGE BOARD, addressed to National Archives of Singapore, 1 Canning Rise, Singapore 179868, Attention: Archives Reading Room Manager. Please see overleaf for the reproduction cost.

**Type 2:** Archival and Administrative fee at S\$500.00 (exclusive of GST) per photograph/image/record, per usage applies to the use of archival materials for product development or commercial use, including in all forms of merchandising, broadcast programme that is not public service type, display in businesses and advertisements.

### What You Should Know Before You Place Your Order

1. Photographic negatives in the National Archives of Singapore (NAS) come from many sources and vary considerably in technical quality. The fee for regular service provides the purchaser with a photographic print of custom (not exhibition) quality. It does not provide for special paper or special effects, nor does it guarantee a print identical to the file print.
2. NAS will print the entire negative surface of an image reproduction order. Hence, images reproduced may differ from the reference copy.
3. 4 working days are required for the reproduction of images no larger than 8R size and not more than 8 copies per order. Bulk orders of more than 8 images might take longer, depending on the number of copies ordered.
4. We seek your kind understanding of any slow-down in meeting orders for images should the Archives Reading Room experience a high volume of reproduction orders.
